History of the preparation

Institute for Collective Action appeals for a day of protest on January 26th

On the 26th of January protest actions will take place all around the world under the initiative of the World Social Forum - under the traditional slogan "Another world is possible". In the frames of this day Union of Coordinating Councils of Russia is going to organize protest actions under the slogan "For civil rights and social justice" and invites all social, civil nets and political oppositions for participation.

About the sense of world solidarity.

New international movement appeared in the world in 1999 - "antiglobalist" or "alterglobalist". It is the net union of social movements and civil initiatives of different countries, struggling in different spheres (housing, labor, educational, ecological, civil, and remedial) for liberation people from dictates of the capitalist globalization. All these movements and initiatives have different political views and methods, but all of them unite under the common slogan "Another world is possible!" The common ideas are as follows. There are millions of us - oppressed, exploitable, and deceived - all around the world. Everyone separately in his block, town, country, movement - can't influence the whole world course of the reach countries governments and large business structures. But when we are together we are strong. And we will show our strength on the 26th of January during the universal day of common actions. "Antiglobalist" movement participants are not extremists and pogrom-makers but ordinary workers, pensioners, students, peasants, who refuse to live in the world where instead of justice impudence of oligarchy and market economy dictates reign, where instead of human values principle "man is an article of trade". This is the mass movement, the volumes of which Russia has never seen before. Almost tens of thousands of people, activists from different countries, assemble to the international social forums. To some demonstrations (e.g. in Genoa in July, 2001 or in Florence in November, 2002) - up to the million! {{Why is it necessary for Russia?}} First of all it is exemplary in the view of mass character and solidarity between people of different countries and different specific interests. Secondly it is a unique chance for Russian movements to leave the isolation. Many members of native initiative groups, trade unions, human rights organizations rely on the international help. Let's help ourselves, them to reach more or less just world! Thirdly, all problems against which we fight here in Russia have common roots with capitalist globalization, which is attacking all around the world. Small

salaries? It is the result of international competition and large capitals dictates. Tightening building up, evection, rise of taxes for housing and communal services? It is the common world politics of land privatization, speculation and impudence of the construction building. Corruption? Man can be bought and sold. Forest felling? Everything in the world must bring money. Education for money and beyond the reach? It is the capitalist logic according to which only solvent citizenry have got any rights (or rather they buy them).

If you don't want to live in the world where social injustice reigns take part in the 26th January actions. Show to the world that there active and thinking citizenry in Russia who resist antisocial course of the authorities and business! Demonstrate yourself and all of us that man is not an article of trade!

January, 26th - the Day of common actions "For civil rights and social justice". Russian social movements are going to participate in the international Day of common actions for civil rights and social justice. At the call of the World Social Forum protest actions will take place all around the world on the 26th of January - under the traditional slogan "Another world is possible".

Actions will be organized by social, trade union and human rights movements and will take place at one day for the vivid demonstration of solidarity of people from different countries, struggling for the fair world order and against the capitalist globalization. In the frames of this day several Russian nets and social organizations are preparing different initiatives. In particular, the Union of Coordinating Councils of Russia (UCC) is going to carry out the protest actions in almost 20 countries.

For the preparation of the action the UCC is publishing the newspaper holding the information about the antisocial politics of the authorities and about the way how to protect your rights and struggle for social justice. The UCC invites all the other nets and movements (human rights, trade union, housing, ecological, educational) to participate in the preparation of the newspaper and protest actions carrying out.

We suggest lying stress on the street actions. To secure the mass character of the action and the breadth of representation we should try to unite to the maximum all the oppositional civil initiatives.

The idea of action - the previous Duma, where "United Russia" had the majority, passed a wealth of antisocial and antidemocratical laws (every initiative can voice its own list of disagreements). Having got the majority in the new Duma (with the help of unexampled pressure and garbling) they intend to continue their course. But we say "Enough!" And for this we are ready to go out together.

The Chechen republic

On 26 January organization "will save generation" (leader Zarem Sadulayeva) carries out the collection of signatures under a petition to Deputies of the State Duma RF about the adoption of law on the inhabitants of the Chechen republic, who became invalids at the childhood as a result of military actions.

Such people in republic are thousands. Now they are in an extremely difficult situation. Pension from 1000 to 3000 rubles is not capable of ensuring them worthy life. Children are deprived of the possibility to attend school because the schools don't provide conditions for this. Invalids cannot find work, they cannot independently make purchases, even visit of polyclinic is for them a serious problem. For many the mine-explosive or fragmentation injury, obtained in the childhood, deprived them from future.

No compensations in respect of an accident, in contrast to the victims of terrorist acts, these invalids

obtain. They do not obtain those privileges, which have soldiers, who received injuries in the course of military actions. They are placed in the category of the invalids of childhood or invalids on the general disease.

Only State Duma RF can change law about the invalids, so that the state would take upon itself responsibility and would appear to be really concern by the innocent victims of war.

Action will take place at the office of the committee of young people CHR. Will attend approximately hundred people. At this meeting the text will be signed by those being present and it will then pass further collection of signatures.

In Russia actions must also take place in Barnaul and Samara. Information about them will come soon.
